

2019-2020 First-Generation College Scholarship Application

The Ohio Council of Community Schools (OCCS) is proud to offer this First-Generation College Scholarship to students who aspire to be the first in their family to complete college. Scholarships may be awarded for any 4-year college or university (University of Toledo, etc.), 2-year college (Owens Community College, etc.), or trade college leading to a certification (Hamrick Truck Driving School, etc.). This award will be a one-time scholarship ranging from \$500 to \$5,000. If awarded, this scholarship will be available for renewal upon completing a re-application in future years.

I. Eligibility

- a. First-Generation means that your parents have not completed a 4-year college degree
- b. Attended an OCCS-affiliated community (charter) school (grade school or high school)
- c. A cumulative grade point average of 2.0 or higher
- d. Completed a standardized admissions test (ACT or SAT), if applying for a 4-year school

II. Deadlines and Documents

To be considered for the scholarship, OCCS requires the following documents to be submitted by **4:00pm Friday, May 10, 2019:**

- a. 2019-2020 first-generation college scholarship application (including supporting documents)
- b. Evidence the candidate attended an OCCS-affiliated community school
- c. A transcript indicating the candidate's cumulative grade point average
- d. Standardized admissions test results (ACT or SAT), if applying for a 4-year school
- e. Completed essay

III. Selection Process

Upon receipt of a completed scholarship application and **ALL** other required documents, OCCS will verify eligibility and review completed applications. Candidates will be notified by May 23, 2019. Please note, incomplete or late applications will not be considered.
